# WCAB Covid-19 Updates

Fall is here and AMLS had a great webinar presented by Zazil Mijares on A Guide to all things Lien Resolution last month. Here are a few take aways from that webinar and keep in mind WCAB Lien Continuances are being discouraged and judges have been notified that they are not to allow continuances unless there is a **very** good reason. If the parties haven't done enough work before the conferences, they will be going off calendar.

Refer your Lien files out early so discovery and Notices of Hearing can be served.

Trials (including Liens) will start to be in person in October 2021 at most of the CA WCAB's

- CIC trials will take priority
- Lien Conferences will continue to be heard, telephonically
- NO LONGER limited to 3 Lien Conferences
  per judge per session
- <u>individually assigned judges' conference</u> <u>lines</u> remain in place
- New Rule: Lien Trials will NOT be set unless the PTCS are completed by all parties and uploaded prior to the Lien Conference date
- Lien Trials are being conducted through LifeSize virtual courtroom; judge will provide link to the parties
